Here is the information I have collected on my ancestor, Peter Reisher (also spelled Risher) Still looking the maiden name of his wife Susanna and for the maiden name of Catherine, first wife of his son Daniel.

"Time line of Peter Reisher who immigrated to America before 1738, and his only son Daniel who died 1825 Franklin County, PA"

1724, 10 Oct. Baltimore County Land Records. (TB&C, p658) John DIGGES of Prince George County, gentleman, conveys 150 acres of 'Digges Choice' to George COUNCE of Conewago Township adjoining the land of John MORNINGSTAR. [This date is interesting as George Kuntz and wife Catharina (nee Jager) had four children baptized at Hatten Lutheran Church 1722-1729. He immigrated 1732 on the "Pennsylvania Merchant" with Catharina, Hans, Eva and Catharine Coonce. George Kuntz was from Hatten, (Postal Code 67690) in the Northern Alsace according to Annette Burgert in "Emigrants from the Northern Alsace to America" pages 318-9, (Picton Press, 1992). This article mentions the Kuntz, Morningstar and Ungefahr families and shows their connections. "Maria Eva Kuntz, daughter of Joh. George and Catharina (Jager) Kuntz, married 18 Jun 1739 Philip Morgenstern, son of John and Juliana. Catharina Coons, widow of George, wrote her will 9 Jun 1755 Heidelberg Twp, York County, PA. Did George immigrate, buy land, return to Europe and then bring his family over?]

1729? Or 1735? - Birth of Daniel RISHER/REISCHER, son of Peter. First date is computed from a letter written by his son Samuel, second is from his tombstone, First Lutheran Church, Chambersburg, PA. The first date is more likely correct as Daniel repatented the land of his father 1751, Frederick County, MD. The Maryland law at that time gives 21 as the legal age for males. ("Understanding What You Read in Maryland Records" draft copy prepared by Eleanor Cook, Maryland Hall of Records, not yet in publication.)

1738, 4 Jun – Records of the Government Council, 1738" Commission Book, p 38. [Read at the Maryland Hall of Records, 3 Feb 1992] "A Patent of Naturalization issued in Common Form to Peter REISHER, a native of High Germany but now of Baltimore County, planter, and his children Daniel, Susannah, and Elizabeth." [Does this means that Daniel and the other children were born in Germany, not in PA? Talked to several archivists at Maryland Hall of Records. They did not know of any other reason for a person to be naturalized unless they were foreign born. The consensus of opinion was that Peter was hedging his bets' here. The fight over the ownership of the land in this area along the Pennsylvania – Maryland border had escalated this year. At least one person had been killed in the dispute. Peter and his neighbors had more rights as naturalized citizens and in the event that something happened to them, their children were already naturalized and could therefore lawfully inherit. cksl

Others naturalized on the same date – all 'natives of High Germany now planters of Baltimore County' John MORNINGSTAR and his children Philip, Elizabeth and Joanna John Martin UNGEFARE and his children George, Francis and Catherine.

Adam FURNEY and his children Mark, Nicholas, Philip, Charlott, Mary and Clara George COONTZ and his children John, Eva and Catherine Stephen ULDERY and his children Stephen, George, Daniel, John, Elizabeth and Susannah John LAMMON (of Prince George County) and his children John, George, Louisa, , Lenora, Catherine and Margaret.

[Note: Philip FORNEY and his brother Mark both died York County, PA. (Pennsylvania Wills, 1682-1834, F. Edward Wright)]

Children: Christian, Marks, Adam, Eve m. Christian WERTS, Catharine m. Nicholas KIEFBRALER, and Daniel.]

1741, 14 Dec. Records of Rev John Casper Stoever. (Filed under York County, PA) John Michael BIEGLER married Susanna REUSCHER, Conewago. Also in these records: 18 Jun 1739, Philip MORGENSTERN married Maria Eva KUNTZ, Conewago. "Emigrants from the Northern Alsace" (p 73) gives Michael Bigler's date and place of birth as 3 Dec 1707, Ingolsheim, also know as Soultz-sous-Forets (Postal Code 67250) He immigrated 1741 on the "Francis and Ann." He was naturalized 21 Sep 1763, 'German, a member of the Baptist congregation' – Burgett, p 74. [This Susanna is the widow of Pete Reisher, see Frederick County MD Deed dated 21 May 1751.]

1743. St Matthew's Lutheran Church, Conewago, now York County, PA. John Michael, son of John Michael BUGLER, baptized. Sponsors: Peter SCHULTZ, Catherine SCHULTZ. [records begin about this date. Read through 1790 - lots of MORGENSTERN, KUNTZ in the records, plus one ONEGEFAHR but no other BIGLER or any RISHER. This child must have died young as he is not in his father's will.]

1746, 7 Jul. Baltimore County, Maryland Land Patents. (T.B. &E, 191) Joh. George COUNCE of Baltimore County, farmer, conveys 150 acres of 'Digges Choice' to his son John COUNTS, who in return will provide a home, maintenance, etc for the said Joh. George COUNCE and wf Catherine, mother of John COUNCE. [Note that this family was naturalized the same date as that of Peter RISHER and that they also had bought land from John DIGGES.]

1751, 21 May. Frederick County, MD, Deed Bk B, pp396-8. Daniel RISHER from John DIGGES of Little Conewago in Baltimore County for 30 pounds of gold paid to him by Peter RISHER, deceased, father of said Daniel; confirms to Daniel RISHER as son and heir of the said Peter, all that tract of land hereafter described, except the resurvey unto Susannah RISHER, a.k.a. BIGLER, mother of Daniel, as her right of dower. Part of the tract of land called 'Digges Choice' beginning at a branch of Little Codurus Creek, running to the NW corner of Peter WELTEY's line, 150 acres. Signed John DIGGES. Wit: William ELDER, John DARNALL. Recorded 7 Jun 1751. Alienation fine (recording fee) paid.

[This is the deed that leads me to believe that the 1729 birth date may be correct. Daniel would have been only 16 in 1751 if the 1735 birthdate is correct. Too young to have recorded this land without a guardian to sign for him]

1760, 22 May, York County, PA, Deed Bk A, p 516. Thomas ARMORER of York Towne, York County, Esq, and wf Sarah to Daniel REISHER of Baltimore County, MD. Land patented 21 Apr 1759 to Thomas ARMORER by William and Richard PENN. Land in Manheim Twp. Bounds: Land of John MENTION(?) by Maryland patent, land of Peter WELTEE, land of Michael BIGLER, land of John DIGGES (by Maryland patent) land of John SPENELY (?) land of Francis NOLL. 73 Acres. House, outbuildings, gardens, meadows, etc. L97.10.0. Signed Thomas ARMORER, Sarah ARMORER. Wit: Michael DOUDLE, David JAMESON.

1761, 4 Jun. York County, PA, Deed Bk B [can't read page numbers] Daniel REISHER of Manheim Twp yeoman and wf Katrina to John WELTEE of same. Land patented 21 Apr last to Thomas ARMORER. Bounds: John STONTICOM?, by Maryland patent, Peter WELTEE, Michael BEIGLER, John DIGGES, John

SPENCLY?, Francis NOLL. 23 acres. Patent Book AA Vol 2, p 236. City of Philadelphia. Sold to Daniel REISHER 22 May last. Recorded Deed Bk A, p 516. He now sells to Peter WELTEE for L87.10.0. Signed Daniel REISHER, Katrina REISHER. Wit: John WILKINSON, Martin WIYCBRITE? Recorded 29 Feb 1764.

1764, 29 Feb. Will of George UNKAFARE proven York County, PA. Executors: Michael CARLE and Leonard GEISEL. No township given. (German will.) [George UNGEFAHR naturalized 1738 with his father and siblings, the same day as Peter REISHER.]

1764, 20 Nov. Frederick County, MD, Will Book A, p227. Will of Michael BEIGHLER proven. Will written 21 Sep 1763. Michael BEIGHLER, of Frederick County, farmer, "well in body and of perfect mind and memory" L5 to Mark BEIGHLER, son of my brother Mark BEIGHLER, all the rest of my estate to my wife Bosenah (Susannah) Wit: Daniel LEATHERMAN, Matthias HURMAN/HEIRNMAN, John ARNOLD, Bartley BOOKER. Proven by Daniel LEATHERMAN and John ARNOLD.

1767 tax list, York County PA, Paradise Twp. REISCHER, Daniel – saw and grist mill, 80 acres, 6 acres in grain, 2 horses, 2 cows. "History of York County, PA" Vol 1, p1043. George R. Provell, G. Beers, 1907.

1768, 7 Apr, York County, PA, Deed Bk G(?) p 443-7. Daniel REISHER of Paradise Twp, York County, miller and wf Catherine to Henry BAUMAN and Johannes WELTY, both of Manheim Twp, yeoman. Land originally warranted to Michael BIGLER, 10 acres then in Lancaster County, now in York between his plantation and Peter WELTY to be surveyed to him 28 May 1744. Michael BIGLER willed to wife Rosina [should be Susannah] who in turn assigned the warrant to Daniel REISCHER, 18 Nov 1767. Daniel REISCHER and wf Catherine for 5 shillings and other considerations sell to Henry BAUMAN and Johannes WELTY land in Manheim Twp described above, together will all buildings, furnishings etc. Signed Daniel REISCHER, Catherine REISHER. Wit: Theobal SHOLLER (?), Jacob BELLINGER Senr (?) Jnr (?) Recorded Apr 27, 1760 from H.B. and J. W. ` 10 shilling in full of the consideration of the money. Signed Daniel REISCHER Wit: Jacob BELLINGER

1768, 27 Apr. York County, PA, Deed Bk G, pp447-9. Daniel REISCHER of Paradise Twp and wife Catherine to Henry BAUMAN of Manheim Twp, yeoman. Land from John DIGGES of Little Conwago, Gentleman. Land sold 21 May 1751 to Daniel REISCHER by the name of Daniel RISHER, part of a tract called "Digges Choice" Bounds: Little Codorus Creek, Peter WELTY's land. 150 acres. Recorded Frederick County, MD, Deed Bk B, folio 396-8. "By which said indenture there was an exception to the Right of Dower of Susanna RISHER who having since deceased by reason whereof the said Daniel REISHER ____ hereto became sole owner of and entitled to the whole." Daniel REISCHER and wf Catherine. 150 acres for L1050. Signed Daniel REISCHER, Catherine REISCHER. Wit: Hanes STOCK, Jacob BELLMYER, Junr. Catherine being of full age examined separately.

Note: John DIGGES claimed land under a MD patent that actually was in PA. The land was in dispute for many years. One person was killed over the land. For more details on this see PA Archives, Series ____, No ___ and "History of Lancaster, .. by Rupp, 1844. Need to check these citations.]

1768-1770, 1782 tax lists Cumberland County (Franklin County formed from Cumberland 1783) read page by page at Carlisle, Pa. No REISHER or any variation thereof found, although county history states that Peter was a very early settler.

1781, Jan 11, will of John MORGENSTERN York County, PA. Executors: Valentine FISHER and C. MORNINGSTAR. (German will.)

1781 Washington County, PA, Peters Twp. Daniel RISHER: 555 acres, 13 horses, 5 cows, 5 sheep, \$622. "PA Archives, 3rd Series", Vol 22, p 761.

1785 Washington County, PA, Peters Twp. Tax List. Daniel RASHER, 500 acres, 2 horses, 5 cows, \$285

1789, Feb 2. Will of Philip MORNINGSTAR, Manheim Township. York County, written. Executors: Michael CARL and George MORNINGSTAR. Children: George, Henry, Catharine m. Peter SHULTZ, Juliana m. Frederick SOWER, Ann m. Nicholas HULL, Elizabeth m. John FELTY, Salome m. Philip MORNINGSTAR, John, and Adam. Will proven 3 Apr 1789.

1790 PA census – Allegheny County,

RISER, Daniel: 3 m>16, 2 m<16, 3 f., RISHER, John: 1 m>16, 1 m<16, 4f.

1793 – Daniel Reisher bought land in Franklin County PA. [Microfilm copy is too poor to read description.]

1798, Mar 30. "Warrantees of Land, Franklin County, Daniel RISHER, 103.70 acres surveyed. 'Pennsylvania Archives', 3rd Series, Vol. II, p 39.

1799, May 14. Franklin County, Pa, Deed Bk 5, p 88. Daniel RISHER and wife Catherine sell land in Chambersburg to Jacob HEYSER. [Both Daniel and Catherine sign in German.]

1799, May 14. Harrison County, VA. Deed Book 4, p 128. Jacob and Catherine HEYSER of Chambersburg, Franklin County, PA, sell to Daniel RISHER of same for 150 pounds, 190.6 acres on Suds Run... sold to sd HEYSER by Alexander and Bathsheba McCLELAND. Signed Jacob and Catherine HEYSER. Wit: John SHRYTOK, James RIDDLE. Recorded Jun 1799.

1799, Oct 28. Daniel REISHER married Mrs. Christina SMITH KROFT, widow of John KROFT. [This date is given in Christina's application for Revolutionary War pension of John KROFT. Is this date correct? His first wife Catherine was still living May 14 – see above deed.]

1801, Sep 14. Harrison County, VA, (now WVA). Deed Book 4, p 417. Daniel RISHER and wife Christina of Chambersburg, Franklin County, PA, sell to Ludwick HECK, carpenter of same for 150 pounds, 290 acres on Suds Run.. sold by Alexander and Bathsheba McCLELLAND to Jacob and Catherine HEYSER who sold to said RISHER. Signed Daniel RISHER and Christina (x) RISHER. Wit: James RIDDLE, PA, J.P., Samuel RADSBURGH. Recorded Oct 1801.

1804, Sep 7. Franklin County, PA. Will Bk B, p213. Letters of administration filed on the estate of Christian GARVER by Michael MILLER. Surety John STEMY and Daniel RESHER.

1813, April 1. Franklin County, PA, Deed Bk 11, p65. Daniel REISHER and wf Christina sell to Jacob HART lot #261 in Chambersburg.

1820, 9 Sep – Daniel REISHER wrote his will (see below)

1825, Apr 9 Will of Daniel REISHER probated, Chambersburg, Franklin County, PA, Will Bk C, p744. Will written Sep 9, 1820.

SMITH KROFT) to his cousin Rev. Levi RISHER of Dravosburg, PA, written 2 Dec 1891.

'My dear friend – Your welcome letter is duly received. Weak and feeble in body from the great age that the heavenly Father has blessed me with. My hearing is greatly impaired. Still notwithstanding, I am still able to see and attend to my business affairs. It is now 26 years since you were with us in Chambersburg after the house was built after the rebels had burnt our lovely town your amiable and lovely nace (niece) Dellia M. RISHER for whom I have great esteem frequently did call to see us while a scholar at Wilson College. from her we heard from you at various times. I see from your letter your endeavoring to find where my ancestry hailed from. My father who was Daniel RISHER who wrote his name as you in German. He was of German descent whose parents came to this country at an early day when this country was but collonies before the revolution. His father having died and he was left his widowed mother then but a child of tender years. Thus you will see my father Daniel RISHER grew to manhood in times of great troubles of the times then existing. He subsquently got maried and had sons and daughters born to him and after these children had been born the mother died. This scattered the children westward the sons were called by name the first Michael, Abraham, David, John and the youngest was Daniel. The daughters were Elizabeth, Mary, and Catherine. It will now be seen that after the death of the mother of the aforesaid sons and daughters my father then married my mother Christina CROFT a widow of John CROFT a soldier of the revolution. So that from this wedlock I was born and my father and mother then lived and remained with me in Chambersburg until death and are both buried in Chambersburg.

It will [be]seen that his sons Michael and the other sons went to west and remained there while I was born in Chambersburg. And there have lived to the present day. So this will show where out name became east and west from the same ancestry and never at any times met so see each other.

My father wrote his name as you do yours. My name has been wrote by me with the REISHER that was followed up from my school days. I am sure that my parents are of German descent and owned the land at one time after Braddock('s) fight with Indians (and) french of which he took part was owned and occupied by father as you do now.

Dear friend you will please to excuse my writing and errors from spelling or any other information you desire you can find from me if desired.

My father's age was 96 years of age when he died. I am within months of 90. [Note at the bottom –"born Aug 13, 1802." [If the age 96 is correct, then Daniel Senior was born c 1729.]


