ALLEN, Joseph T., Private, born 2 May 1838, Hampshire Co., died

31 July 1915, buried Mt. Zion Cemetery. Enlisted 16 Feb. 1865, discharged 30 June 1865, Company E, 17th West Virginia Vol. Infantry. Union.

AMOS, Rowley W., Private, Company E, 10th West Virginia Infantry, and Company G, 10th Regt., West Virginia Infantry. Enlisted 1861, discharged 1865. Union.

ANDERSON, Nathaniel, Private, born 1830, died 30 July 1892, buried Lamb Cemetery. Enlisted 30 Dec. 1861, Company A, 3rd Regt., West Virginia Cavalry. Listed as deserted at Camp Parole, Annapolis, Md., 18 Jan. 1863. Union.

ARNOLD, John A., Private, Co. E, 14th Virginia Cavalry. Born in Va. 28 Sep. 1843. Enlisted in Calhoun Co., Va. 26 Sep. 1862. Presence or absence not stated January to February 1863. Present 30 April 1863. Captured in Calhoun Co., Va. 12 Jan. 1864 as deserter. Sent to Wheeling. Age 20, 5' 8", pale complexion, hazel eyes, dark hair, farmer, Calhoun Co., Va. Transferred to Camp Chase. Took oath and released 8 Feb. 1865. Farmer, Age 27, Washington Township, 1870 Calhoun Co. Census. Died 5 Nov. 1927. Buried in Walnut Church Cemetery, Calhoun Co., W.Va. (23' West of Mary E. Johnson's grave). C.S.A.

ASHBY, James, Private, Company K, 39th WSC Troops. Enlisted July 1864, discharged 1865.

AYERS, Adolphus B., Private, born 1843, died 1918, buried Nobe Cemetery. Enlisted 22 Dec. 1861, Company C, 11th Regt., West Virginia Infantry. Union.

AYERS, Michael, an original Company C recruit; later Major, commanding company at its surrender. Union.

AYERS, Salem V., Private, Company C, 11th West Virginia Infantry, captured at Bulltown 13 Oct. 1863. Enlisted 22 Dec. 1861, discharged 1864. Wife, Lucy E., receiving \$8.00 per month widows pension on 1883 Pension Roll; address, White Pine. Union.

BADGET, Shadrach A., Private, born Augusta Co., Va., 27 Mar. 1828, died 12 June 1900, buried Clark Jarvis farm cemetery, White Oak. Enlisted 1 Jan. 1862, Company G, 9th Regt., West Virginia Volunteer Infantry, for three years. Re-enlisted in Company E, lst Regt., West Virginia Vet. Volunteer Infantry. Discharged 25 July

1865. Wounded 9 May 1864 at Cloyd's Mountain. Union.

BAILEY, A. J., 3rd Lieutenant, Company E, 14th Virginia Cavalry. C.S.A.

BAILEY, Addison H., 1st Lieutenant, Co. E, 14th Virginia Cavalry. Born Logan Co., Va. 29 Dec. 1844. Enlisted in Calhoun Co., Va. 26 Sep. 1862 as 2nd Lieutenant. Presence or absence not stated January to February 1863. Present Saltville with 21 men 22 Apr 1863. Captured in Calhoun Co., Va. 13 Jan. 1864. Sent to Wheeling. Age 19, 5' 9 1/2", fair complexion, gray eyes, dark hair, residence in Calhoun Co., Va. Transferred to Camp Chase and Ft. Delaware. Probably 1st Lieutenant while prisoner of war 26 May 1864. Released 16 June 1865. Farmer, age 25, Washington Township, Calhoun County 1870 Census. Died 1935. Buried in Tariff Cemetery, Roane Co., W.Va. Member of R. E. Lee Camp 887, Confederate Veterans. Residence Tariff, W.Va. 1915. C.S.A.

BAILEY, Carr, Son of Joseph Bailey. Buried in unmarked grave beside Mr. and Mrs. Governor Wise Clark in Liberty Hill Cemetery. Born 16 Apr. 1837, died 25 May 1924. Union.

BAILEY, Dodridge E., Sergeant, Co. E, 14th Virginia Cavalry. Born Fauquier Co., Va. 4 May 1835. Age 25, Arnoldsburg, Calhoun Co., 1860 Census. Enlisted Calhoun Co., Va. 26 Sep. 1862 as Private. Absent in charge of horses January to April 1863. Captured in Calhoun Co., Va. 14 January 1864. Sent to Wheeling. Age 30, 5' 11", dark complexion, brown hair, farmer residing in Calhoun Co. Transferred to Camp Chase. Took oath and released 17 Jan. 1865. 27th Regt. Virginia Infantry. Farmer, age 35, Washington Township, Calhoun Co. 1870 Census. Died 23 Feb. 1893. Buried in Bailey Cemetery. Brother of William A. Bailey. Son of John Bailey. Nephew of James H. and William W. Bailey. C.S.A.

BAILEY, James Harvey, 1st Lieutenant, Co. E, 14th Virginia Cavalry. Enlisted in Calhoun Co., Va. 26 June (?) 1862 as 5th Sergeant. Absent on detached duty January and February 1863. Born 5 Mar. 1818, died 23 Feb. 1863. Killed in action on Blown Timber 23 Feb. 1863 by Home Guards. Was shot in the yard at his home, then shot a second time in his wife's arms as she begged them not to shoot him again. Buried in the Bailey Cemetery on Allan Tizer farm. Father of Addison Howard Bailey, brother of William W. Bailey. C.S.A.

BAILEY, William A., Private, Co. E, 14th Virginia Cavalry. Born in Mercer Co., Va. 1839. Farmer, age 22, Calhoun Co. Va. 1860 Census. Enlisted in Calhoun Co. 26 Sep. 1862. Presence or absence not stated January to February 1863. Present 30 April 1863 and 20 Sep. 1864. Captured at Cedarville 12 Nov. 1864. Sent to Point Lookout. Released 5 June 1865. Farmer, age 33, Washington Township, Calhoun Co. 1870 Census. Buried in Minnora Cemetery (16' North of Samuel T. Isenhart's grave). Brother of Dodridge Bailey. Son of John Bailey. Nephew of James H. and William W. Bailey. C.S.A.

BAILEY, William W. (H.), [See PHOTO], 2nd Sergeant, Co. E/F, 14th Virginia Cavalry. Born Tazewell Co., Va. 10 June 1816. Enlisted at Minnora, Calhoun Co., Va. 26 Sep. 1862. Absent in charge of horses January to April 1863. Served as Sergeant orderly of Company F, afterwards forage master for regiment. Participated in battles at Winchester, Gettysburg, twice at Brandy Station, Cloyd's Mountain, Bulltown, and numerous skirmishes. Discharged 12 Sep 1863 (had only one arm). Paroled at Charleston 25 May 1865, age 48, 5' 11", dark complexion, blue eyes, gray hair. Farmer, age 53, Washington Township, Calhoun Co. 1870 Census. Died 28 Oct. 1897. Buried in Bailey Cemetery, Joe Bailey Farm, Calhoun Co., W.Va. C.S.A.

BALL, Emery (Emory, Emerey) Madison, 4th Sergeant, Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted 15 July 1861 in Calhoun Co., Va. Private Co. A, 19th Virginia Cavalry. Born Calhoun (Lewis) Co.1841-1843. Age 17, farmer, Calhoun Co. 1860 Census. Enlisted Williamsburg, Greenbrier County, W.Va. 1 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863. Enlisted in 20th Virginia Cavalry, Company H, at Camp Northwest, W.Va. on 1 June 1863. Elected 1st Lieutenant 4 June 1863. Commanding Company H, 2 Oct. 1863. Absent in arrest 31 Oct. 1863-31 Aug. 1864. Absent 1 Sep. 1864-31 Oct. 1864 (dated 30 Dec. 1864) in arrest. Absent 15 Dec. 1864, listed as prisoner of war since 31 Oct. 1863. Deserted. Reported to U.S. Forces 25 Dec. 1864, took the oath of allegiance and gave his bond. He lived in Center District, Calhoun County. Age 27, farmer, Center District, Calhoun Co., W.Va. 1870 Census. Age 39, farmer, Center District, Calhoun Co., W.Va. 1880 Cenus. He died in 1918 and is buried in Sand Ridge Cemetery, W.Va. (9' South of Perry Hall's grave). C.S.A.

BALL, Franklin, killed in 1861 while acting as a scout on Bear Fork of Steer Creek.

BALL, J., led a band of Home Guards through Calhoun Co., father of Thomas, John, George, and Emery. Union.

BALL, Jasper, Private, born 25 Dec. 1829, Harrison Co., Va., died 29 June 1906, buried Sycamore Cemetery, Company C, 11th West Virginia Infantry. Union.

BALL, John M., Private, Company C, 11th West Virginia Infantry. Enlisted 1862, discharged 1865. Union.

BANUER, Josiah, Private, Company C, 11th Virginia Infantry. Enlisted 1862, discharged 1864. Union.

BARNES, Bennett J., Private, Company S, 10th West Virginia Infantry. Enlisted 1861, discharged 1865. Union.

BARNES, William, Private, in Capt. Jacob Clammer's Company C, 11th Regt., West Virginia Infantry Volunteers, was enrolled 10 Nov. 1861, discharged 24 Dec. 1865 at Cumberland, Maryland. Was born in Allegany Co., Md., age 39 when discharged, 6' tall, fair complexion, gray eyes, brown hair, occupation--farmer. Union.

BARNHOUSE, T. John, Company G, 9th West Virginia Infantry, enlisted 1 Mar. 1862, died of disease. Union.

BARR, Alfred, [See PHOTO], Private, born 25 Sept. 1839, enlisted 22 Dec. 1861, Company C, 11th West Virginia Regt. Left to die on battlefield at Winchester, Va., 25 July 1864. Was nursed back to life by the kind hands of Southern women. When able, was taken to Libby Prison where he was exchanged and taken to hospital at Annapolis, Md. Union.

BASTRUG, Peter P., Company G, 7th West Virginia Infantry. Enlisted 1865, discharged 30 Jan. 1865. Union.

BEALL, Henderson, Private, born Lewis Co., Va. Enlisted at Arnoldsburg 18 Aug. 1862 for three years. Captured 19 Oct. 1864 at Cedar Creek, Va. Died at Pine Bottom, Calhoun Co., 11 Oct. 1865 of chronic disease contracted in service, buried Big Bend Cemetery, Company C, 11th West Virginia Regt. of Volunteers. Discharged 1865. Wife, Leah Bell, receiving \$8.00 per month widows pension on 1883 Pension Roll; address, Grantsville. Union.

BEALL, John M., Private, Company C, 11th Regt., West Virginia

Infantry, mustered 21 Sept. 1862, born 28 Apr. 1830, Lewis Co., died Sept. 1883, buried Rogers Cemetery. Union.

BEALL, Townsend, Private, mustered 22 Dec. 1863, Company C, 11th Regt., West Virginia Infantry. Union.

BEE, Stennett, Sergeant, born 1830, died 1923, buried Bee Cemetery. Company I (or J), 6th West Virginia Infantry. Enlisted 16 Feb. 1865, discharged 10 June 1865. Union.

BEGES, George W., Private, Company B, 85th Pennsylvania Infantry. Enlisted Oct. 1861, discharged Feb. 1864. Union.

BELL, James W., Private, Company A, 1st Virginia Infantry. Enlisted 1861, discharged 1863. C.S.A.

BELL, John M., Private, Co. D, 14th Virginia Cavalry. Born about 1829. Enlisted at Lewisburg 1 Apr. 1864. Farmer, age 41, Center Township, Calhoun Co. 1870 Census. C.S.A.

BELL, Towney, buried Hur Cemetery (10' North of R. W. Bell's grave). C.S.A.

BELT, Hedgman, second Lieutenant, born in Harrison County, 16 Mar. 1833. Enlisted Aug. 1862, discharged 14 June 1865, Company B, 15th West Virginia Infantry. Was in eleven battles. Buried Belt Cemetery, Wirt Co., W.Va. Union.

BELT, Jasper N., Served in Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted on 8 May 1862 in Calhoun Co., Va. "Absent without leave or dead" per 28 Feb. 1863 roll. Private, Co. A., 19th Virginia Cavalry. Born Wirt Co., W.Va. about 1843. He appears on postwar rosters only which show he is a resident of Calhoun Co., W.Va. Age 27, farmer, Sheridan District, Calhoun Co., W.Va. 1870 Census. C.S.A.

BENNETT, Nathan, scouted with Jacob P. Starcher. (There is a N. O. Bennett buried Wright Cemetery, no dates.) C.S.A.

BENNETT, William G., captured with Peter Starcher. Acted as Captain of a squad of men at Glenville. C.S.A.

BERKHOUSE, Benjamin, Private.

BETH, John R., Private.

BIGLER, George W., Private.

BILLFIE, Private.

BISHOP, John, Private, Company I, 53rd Kentucky Infantry. Enlisted 1864, discharged 1865. Union.

BLAIR, Lindsey, born 11 Sept. 1837, Greenup, Ky., died Clarksburg, W.Va., 6 Oct. 1930. He was a son of Jeremiah and Ruschia Mullin Blair. He enlisted in 1861 at Burning Springs in Company K of 2nd West Virginia Infantry, serving under Capt. Andrew Grubb. Soon after the "Philippi races," 3 June 1861 he was in the Laurel Hill and the skirmish at Corrick's Ford, north of Elkins, where Gen. Robert S. Garnett, Confederate general, was killed. Blair took part in thirty-seven engagements, many important battles along the Greenbrier River, was in the Richmond and Potomac campaigns. Captured at Jackson River in Virginia, he was imprisoned at Andersonville Prison for twelve months, suffering exposure to the weather, thirst, starvation, and inhumane treatment. He said he lived on a pint of cornmeal a day in the prison. At the end of the vear he was transferred to Belle Island Prison on the James River in Virginia, where he remained for four months and until the end of the war. Men froze to death, he said, in that prison. Mustered out at Wheeling he returned home and married Sarah Johnson and they had six sons and daughters; after her death he married Frona Deems, daughter of Isaiah and Harriet Nutter Deems and they had ten children. Union.

BLAKE, John T., Private, born 18 Dec. 1829, died 10 June 1911, buried Mount Zion Cemetery. Enlisted 10 Sept. 1862, Company F, 15th West Virginia Infantry, discharged 14 June 1865. Union.

BLAND, Henry H., Private, born 15 Apr. 1841, Richland Co., Ohio, died at Howard, Okla., 6 May 1907, buried Bethlehem Cemetery, Calhoun Co. Enrolled 14 Oct. 1861 at Wheeling, Va., Company K, lst Regt., West Virginia Infantry. Honorably discharged at Wheeling on 28 Nov. 1864, 20 years, 5'10', sandy complexion, black eyes, dark hair. Contracted typhoid fever in June 1862, which resulted in rheumatism, heart and back problems. Was treated in hospitals at Alexandria, Va., Point Lookout near Washington, D.C. Married Perie Ann Renner at Greene Co., Pa., 31 Dec. 1865, children: Martha, Susan, Mary, Lorney, Clara, Andrew J., Rachel, James, Virginia, Levi, and Arthur. Union.

BOGGS, William H., Private, Company B, 11th West Virginia Infantry, enlisted Nov. 1862, discharged 1864. Union.

BONER, Amos, (See BUNNER, Amos), [See PHOTO].

BONER, Ferrell D., Private, born Monongalia Co., Va., mustered 22 Dec. 1861, Company C, 11th Regt., West Virginia Infantry. Union.

BONER, Hiram, Private, born 1839, Marion Co., buried Freed Cemetery. Enlisted 27 Aug. 1862, discharged Feb. 1863, due to disability. Company H, 12th West Virginia Infantry. Union. (This name also spelled Bunner.) [According to the 1864 WV Adjutant General's Report, Hyram/Hiram Bonar, 29, born in Marion County, was in the 12th Infantry, 27 Aug 1862-Feb 1863, at which time he was honorably discharged on account of disability. -- At age 33, he mustered in with Company "B" of the 17th Inf on 30 Aug 1864. The 1864 Adjutant General's Report of his record in the 17th Infantry states: "Served 9 months in 12th Inf. Honorably Discharged."]

BONER, James, Private, mustered 22 Dec. 1861, Company C, 11th Regt., West Virginia Infantry, born 1845. Union.

BONER, Jonah, born 1843, buried Freed Cemetery. Enlisted 22 Dec. 1861, discharged 16 June 1865, captured at Cedar Creek, Va., 19 Oct. 1864, Company C, 11th West Virginia Infantry. Union.

BONER, Robert, Private, born 1820, Monongalia Co., Va., Company C, 11th Regt., West Virginia Infantry. Union.

BONER, Valentine, Private, born 1841, Monongalia Co., Va., Company C, 11th Regt., West Virginia Infantry. Union.

BOOHER, Peter M., Private, buried Mt. Zion Cemetery. Enlisted 24 Dec. 1863, discharged Feb. 1864, Company C, 11th West Virginia Infantry. Wounded in head, lost sight. Union.

BOURNE, John S., Private, born 1843, buried in Metz Cemetery (4' North of Laura L. Bourne's grave). Mustered 25 Aug. 1862, Company F, 1st Regt., Veterans Infantry. Came home, had typhoid, war ended before his return. Union.

BOURNE, William, Private, born 1840, Elmira, Braxton Co., was nearly killed when his hat was struck with sword as he jumped a fence. Mustered 25 Aug. 1862, Company F, 1st Regt., Veterans Infantry. Union.

BOWER, Oliver P., Private, born 3 Sept. 1841, Marion Co., Va., died 11 Dec. 1919, buried in Big Bend Cemetery. Company F, 7th Regt., West Virginia Infantry. Substituted for L. C. Elliott. Believed also served Company B, 2nd West Virginia Infantry, May 1861 to July 1865. Receiving \$4.00 per month pension for injury to left knee on 1883 Pension Roll; address, Brooksville. Union.

BOYERS, James, born 31 Mar. 1831, Greenbrier Co., died 11 Apr. 1921 (or 1929) buried in Mt. Zion Cemetery (2' East of Joseph Summers' grave). C.S.A.

BOYLES, Daniel, Private, disability. Ague.

BOYLES, David A., Sergeant, Company F, 15th West Virginia Infantry, born 1831 or 1834, Randolph Co., Va., died 19 Aug. 1889, buried Mt. Zion Cemetery. Union.

BRAKE, Jerome L. D., Private, 10th West Virginia Infantry, enlisted 1864, discharged 1865. Union.

BRANNON, Abraham H., Private, Co. E, 14th Virginia Cavalry. Born about 1845. Enlisted in Calhoun Co., Va. 26 Sep. 1862. Absent on detached duty in Calhoun Co. January to February 1863. Present 30 April 1863. Deserted July 1863. Captured in Calhoun Co. 14 Jan. 1864. Sent to Wheeling. Age 21, 5' 8", florid complexion, gray eyes, brown hair, farmer, Calhoun Co., Va. Transferred to Camp Chase. Took oath and released 9 Jan. 1865. Illiterate. C.S.A.

BRANNON, Henry, Co. A., 3rd Virginia State Line (Moccasin Rangers). Enlisted on 1 Nov. 1862 in Nicholas Co., Va. Present on 28 Feb. 1863. Private, Co. A., 19th Virginia Cavalry. Born 15 Sep. 1831 in Jackson Co., W.Va. Enlisted Williamsburg, Greenbrier Co., W. Va. 1 Mar. 1863. Witnessed the killing of Alva L. Laughlin, Union soldier, by Confederate soldiers in Pocahontas Co. on or about the 24th day of July 1863. Deserted. Captured 30 Oct. 1863 in Calhoun Co. Confined at the Atheneum Prison 20 Nov. 1863. Transferred to Camp Chase 20 Nov. 1863. Confined at Camp Chase 21 Nov 1863. Desires to take the oath of allegiance 10 June 1864. Statement at Camp Chase 25 Jan. 1865 lists his age as 33 and from Calhoun County. He says he went to the store of Absalom Knotts (a rebel recruiting officer) who tried to persuade him to enlist in his company. Brannon refused and went home. Several days later he was taken by a guard of three men and sent to Monroe Co., W.Va.

Deserted during the night of 30 Oct. 1863 and went home. Asks now that he be released. Released by order of the Secretary of War, 17 Feb. 1865, after taking the oath of allegiance. Petition submitted for his release. Description, age 33, 5' 7", dark complexion, black hair and blue eyes, farmer, resident of Calhoun Co., W.Va. Buried with second wife, Jane, in the Cottrell Cemetery in Beech. C.S.A.

BRANNON (BRANNAN), Jacob P., Private, Co. E, 14th Virginia Cavalry. Born about 1847. Enlisted in Calhoun Co., Va. 26 Sep. 1862. Present 30 Apr. 1863. Captured in Calhoun Co., 14 Jan. 1864 as deserter. Age 20, 5' 5", light complexion, gray eyes, brown hair, farmer, Calhoun Co., W. Va. Sent to Wheeling and transferred to Camp Chase. Took oath and released 6 Jan. 1865. C.S.A.

BRANNON, John Jr., Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted on 1 Nov. 1862 in Nicholas Co., Va. Present on 28 Feb. 1863. Sergeant, Co. A., 19th Virginia Cavalry. Born about 1833 in Jackson County. Enlisted Williamsburg, Greenbrier County, 1 Mar. 1863. Deserted. Captured Calhoun Co. 30 Oct. 1863. Confined at the Atheneum Prison 20 Nov. 1863. Description: Age 30, 5' 10", dark complexion, dark hair, and hazel eyes. Transferred to Camp Chase 20 Nov. 1863. Confined at Camp Chase 21 Nov. 1863. Desires to take the oath of allegiance 10 June 1864. Took the oath of allegiance and was released by order of the Secretary of War, 17 Feb. 1865. Lived in Lee District, Calhoun Co. 1880 Census. Postwar resident of Nicholas Co., W.Va. C.S.A.

BRANNON, William H., Company G, 9th West Virginia Infantry. Killed at Cloyd's Farm, Va., 9 Mar. 1864. Union.

BRANNON, William L., served three years. C.S.A.

BROOKOVER, Eli, Private, born 18 Apr. 1824, died 4 Apr. 1892, buried Metz Cemetery. Enlisted 25 Feb. 1865, Company H, 1st West Virginia Infantry, discharged 18 July 1865. Union.

BROOKS, Andrew T., Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted on 15 Aug. 1862 in Calhoun Co., Va. Detailed on 9 Dec. 1862 as Commissary Sergeant. Private Co. A, 19th Virginia Cavalry. Born Pa. Resident of Calhoun County, W.Va. Enl. Williamsburg, Greenbrier Co., W.Va. 1 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863. Employed as a laborer at Warm Springs, on extra duty, 1 Jan. 1864-31 Mar. 1864. Clothing issued 19 Feb. 1864, 23 Feb. 1864, 21 May 1864,

and 17 June 1864. Captured Loudoun County near Harper's Ferry 16 July 1864, and sent to Washington, D. C. 20 July 1864. Confined at the Old Capitol Prison, 20 July 1864. Transferred to Elmira, NY, 23 July 1864. Confined at Elmira Prison, 25 July 1864. Desires to take the oath of allegiance, 3 Sep. 1864, states that he volunteered 28 Feb. 1863, and has lived in Ohio, where he now wishes to go. Captured Calhoun Co., W.Va., 7 Nov. 1864 (29 Oct. 1864). Confined at the Atheneum Prison, Nov. 1864. Description: Age 31, 5' 7", dark complexion, dark hair, and black eyes. Occupation, farmer residing in Calhoun Co., W.Va. Transferred to Camp Chase 29 Nov. 1864. Confined at Camp Chase 30 Nov. 1864, desires to take the oath of allegiance. Statement at Camp Chase, 26 Jan. 1865, lists him as a resident of Calhoun Co., W.Va., age 33. Was arrested by the Home Guards of Roane Co., W.Va., 29 Oct. 1864. States he was induced to enlist 1 Sep. 1862 for 12 months. At the expiration of his term, he was conscripted. Became sick July 1864 and was sent to a hospital. When well enough, he went to Pocahontas Co., W.Va. on sick leave, and was arrested while sick. Took the oath of allegiance and was released 18 Feb. 1865. C.S.A.

Post war rosters only. Wounded Arnoldsburg, W.Va. 6 May 1862, crippled for life. Age 35, farmer, Washington Township, Calhoun Co., W.Va. 1870 Census. Age 47, farmer, Washington District, Calhoun Co., W.Va. 1880 Census. C.S.A.

DOWNS, George, [See PHOTO], Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted 15 July 1861 in Calhoun Co., Va. Tried and imprisoned by a Federal court for leading a raid on the Post Office at Ripley, W.Va., 19 Dec. 1861. Major/Captain, Co. A,

19th Virginia Cavalry. Born Monongalia Co., W.Va. 7 Apr. 1820. Age 39, miller, Calhoun Co., W.Va. 1860 Census. Captured at Big Bend, W.Va. 2 July 1862. Confined at Parkersburg and Camp Chase. Sent to Camp Chase as "guerillas, 1st Va. Rangers." Then age 42, 5' 10', dark complexion, grey eyes, sandy hair, occupation: miller. Exchanged at Vicksburg Miss. on 22 Nov. 1862. Rerecruited his command among exchanged prisoners at Vicksburg in early December 1862. This unit was originally recruited in Calhoun Co., Va. as partisan rangers and was recognized as Co. Jackson promoted him to Major at Warm Springs, 22 Apr. 1864, "on account of his qualifications, his marked gallantry on several occasions, his influence in the Regiment." Appointed Major 28 June 1864, to rank from 26 Feb. 1864. Accepted the appoinment 18 Aug. 1864. His appointment was confirmed 5 Jan. 1865. Absent F&S MR 1 Sep. 1864-31 Oct. 1864. Wounded Lynchburg, 17 June 1864. Applied for a furlough at Staunton, 9 July 1864. Admitted General Hospital No. 1, Lynchburg, there on 14 July 1864, returned to duty. action in Jackson Co., W.Va. on 17 Jan. 1863. Born in Lewis Co., W.Va. about 1842. Age 18, Calhoun Co., W.Va. 1860 Census. Brother of George W. Duskey, son of Daniel Duskey. C.S.A.

DUSKEY(DUSKY), Daniel, [See PHOTO], Captain, Co. C, 186th Va. militia, 1856. Recruited and commanded one section (company) of 3rd Virginia State Line (Moccasin Rangers). Private, Co. A, 19th Virginia Cavalry. Born Alleghany Co., Pa. 1809. Age 51, farmer, Calhoun Co., W.Va. 1860 Census. Justice of the Peace, Calhoun Co., W.Va. Captured Wirt Co., W.Va. 15 Dec. 1861 with 33 of his men. Confined at the Atheneum Prison, under heavy guard. Indicted for treason and turned over to the U.S. Marshal for the western division of Va. by 28 Mar. 1862. Tried by U.S. Court in Western Virginia, 14 Apr. 1862, for robbing the Post Office at Ripley, W.Va.; convicted and sentenced to four years in prison; imprisoned at Albany, N.Y. before 11 June 1863. Released by Presidential Pardon, 17 June 1863. Returned to the Little Kanawha Valley, not on muster rolls. Captured Webster Co., W.Va. 9 Feb. 1864. Sent to Cumberland, Md., then to Wheeling, W.Va. Confined at the Atheneum Prison 21 Feb. 1864. Description: age 55, 5' 7", fair complexion, brown hair and gray eyes. Occupation, farmer residing in Calhoun Co., W.Va. Charged with being a bushwhacker. Escaped from military prison 18 July 1865. It is said that he boasted that "he had a little graveyard of his own in which he buried a considerable number of Union men." Post war source lists him as Captain. Father of Andrew and George Duskey. C.S.A.

DUSKEY (DUSKY), George W., Co. A, 3rd Virginia State Line (Moccasin Rangers). Commissioned Captain of Infantry on 18 Sep. 1862. On August's list of Virginia State Line Officers prepared on 27 Jan. 1863. On T. E. Davis' list of Virginia State Line Officers dated 28 Feb. 1863. Private, Co. C, 19th Virginia Cavalry. Born Lewis Co., W.Va. about 1840. Age 20, Calhoun Co. 1860 Census. Captured Wirt Co., W.Va. 15 Dec. 1861. Confined at the Atheneum Prison under heavy guard. Pretended to be ill and was sent to the Sprigg Hill Hospital, Wheeling, W.Va. While there he escaped with a few of his men, including Josiah Parsons, and returned to Calhoun Co., W.Va. and there reorganized the Moccasin Rangers. Enlisted Pocahontas Co., W.Va. 1 Apr. 1863. Absent 31 Dec. 1863 to 31 Aug. 1864. Has one horse; captured Roane Co., W.Va., 20 June 1863. Absent 1 Sep. 1864-31 Oct. 1864, \$100 enlistment bounty due. Was reported on 29 Nov. 1864 that Duskey and Lieutenant William A. Gandy were being held in solitary confinement, and to

be sent to Ft. Monroe for exchange, 21 Jan. 1865. Reported as being held in the Wheeling City Jail which served as a State prison, 25 Jan. 1865. Duskey being held by civil authorities, under indictment for treason and robbing the mail (Ripley, W.Va. Post Office). Captured 2 Feb. 1865, no place stated. (This is probably their release date from prison and the time that the military took control of them again.) Confined at Baltimore, Md., then sent to Camp Hamilton. Transportation to Ft. Monroe for Duskey and William Gandy ordered 4 Feb. 1865. Confined at Camp Hamilton, Va. military prison awaiting exchange 6 Feb. 1865. Released 11 Feb. 1865. Post war rosters show service in Co. A. Not stated if present or absent on muster-inroll dated March 1863. Deserted. Captured Calhoun (Roane) Co., W.Va. 1 Nov. 1863. Confined at the Atheneum Prison, 20 Nov. 1863. Description, age 34, 6', light complexion, brown hair and blue eyes; Occupation, farmer, residing in Roane Co., W.Va. Transferred to Camp Chase, 20 Nov. 1863. Confined at Camp Chase, 21 Nov. 1863. Paroled at Charleston, W.Va., 10 May 1865, listed as belonging to Co. A, 19th Virginia Cavalry. Signs oath by X. Description, age 38, 6', dark complexion, dark hair, and dark eyes. Post war resident of Calhoun and Ritchie Counties, W.Va. Age 61 (?), farmer, Murphy District, Ritchie Co., W.Va. 1880 Census. C.S.A.

Clothing issued 2 Feb. 1864 and 19 Feb. 1864. Captured Roane Co., W.Va., 23 Apr. 1864. Confined at the Atheneum Prison, 2 May 1846. Description, age 23, 6', fresh complexion, light hair and blue eyes. Occupation farmer, residing in Roane Co., W.Va. Transferred to Camp Chase 10 May 1864. Confined at Camp Chase 11 May 1864. Admitted to Chase U.S.A. General Hospital, Camp Chase, 9 Sep. 1864, variolla. Returned to duty 5 Oct. 1864, age 23, not vaccinated. Gave statement at Camp Chase, 25 Jan. 1865, listed as age 23, a resident of Calhoun Co., W.Va. Was arrested in Roane

Absent, 2nd Sergeant 31 Dec. 1863-31 Aug. 1864, had one horse. Promoted to 2nd Sergeant 15 Feb. 1864. Post war rosters show service in Co. A and that he was a resident of Calhoun Co., W.Va. Post war rosters show he was killed in action, Winchester,

1863/died 10 Aug. 1864. C.S.A.

Age 52, farmer, Sheridan District, Calhoun County, WV 1880 Census. C.S.A.

HAYMAKER, Francis, Private, Company C, 11th Pennsylvania Cavalry, enlisted 1864, discharged 1865. Union.

HAYMAKER, Frank L., born 28 Feb. 1843, died 1 Mar. 1892, buried Hays Cemetery. Union.

Represented Gilmer and Wirt Counties in the Va. House of Delegates, 1855-56. Partner with George W. Silcott in the mercantile and land business. Major, Va. Militia, on Gov. Wise's staff. Wealthiest man in Calhoun Co., W.Va., 1860. Served as Sheriff of Calhoun Co., W.Va. 1861. Helped organize the Moccasin Rangers in 1861, along with George W. Silcott. Became disgusted with the actions of the company, and returned to Arnoldsburg, W.Va. Captain Daniel Duskey ordered his arrest for desertion. U.S. forces arrested him, and he was confined at Camp Chase. Paroled, and went to Monroe Co., W.Va. There he served as a purchasing agent for the Confederate States Ouarter Master Department. Despite his commission as Major, Hays enlisted as a Private in Captain George Downs Company of Moccasin Rangers. Entered Spencer, W.Va. with George W. Silcott under a flag of truce and secured a cease fire for eight days from Col. J. C. Rathbone, so Captain Downs' men could visit their homes unmolested. Commissioned as Major by Gov. John Letcher. A, 19th Virginia Cavarly. Enlisted Williamsburg, Va, 1 Mar. 1863. Taken prisoner in Calhoun Co., W.Va. 12 Dec. 1864.

Sent to the Atheneum Prison, 23 Dec. 1864, age 34, 5' 11", dark complexion, brown hair and blue eyes, farmer, residing in Calhoun Co., W.Va. Transferred to Camp Chase 27 Dec. 1864. Desired to take the oath of allegiance. Took the oath, released, 12 June 1865, age 34, 5' 11", light complexion, dark hair and blue eyes, a resident of Calhoun Co., W.Va. C.S.A.

Transferred to Alton, Ill. and to City Point, Va. for exchange on 1 Apr. 1863. Private, Co. A, 19th Virginia Cavalry. Born Greenbrier Co., W.Va. about 1833 (1837). Age 23, farmer, Calhoun Co. 1860 Census. Not on muster rolls. Paid on 18 Oct. 1864 for service from 1 Nov. 1862-28 Feb. 1863. Clothing issued 18 Feb. 1864. Buried Minnora Cemetery, Calhoun Co., W.Va. C.S.A.

Absent sick in hospital Montgomery, White Sulphur Springs June 1863. Prisoner of war Camp Chase on rolls 1 Apr. 1864 to 31 Dec. 1864. No Federal records. C.S.A.

JARVIS, George P., Private, Co. E, 14th Virginia Cavalry. Born in Lewis Co., Va. about 1835. Enlisted in Calhoun Co., Va. 26 Sep. 1862. Discharged for Pulmanalis 16 Jan. 1863, age 28, 5" 8-1/2", dark complexion, blue eyes, light hair, farmer. Re-enlisted 30 Apr. 1863. Captured at Falling Waters, Md. 14 July 1863. Sent to Old Capitol. Transferred to Elmira. Took oath and released 14 Mar. 1864. 5' 6", dark complexion, black hair, dark eyes, illiterate, residence Calhoun Co. C.S.A.

Captured Webster County, W.Va. 23 Feb. 1865 (22 Feb. 1865). Confined at Clarksburg, W.Va., 27 Feb. 1865. Description, age 23, 5' 9", dark complexion, light hair and blue eyes. Occupation, farmer residing in Webster Co., W.Va. Transferred to Wheeling, W.Va., 28 Feb. 1865. Confined at the Atheneum Prison, 28 Feb. 1865. Description, age 23, 5' 9", fair complexion, light hair, gray eyes, a resident of Roane County, W.Va. Transferred to Camp Chase, 1 Mar. 1865. Confined at Camp Chase, 2 Mar. 1865. C.S.A. Joined U.S. service, 20 Mar. 1865 and was sent to Chicago, Ill. Union.

TANNER, Lorenzo D(ow), Co. A 3rd Virginia State Line (Moccasin Rangers). Enlisted on 6 May 1862 in Calhoun Co., Va. Present on 28 Feb. 1863. Private, Co. A, 19th Virginia Cavalry. Born 1845. Post war rosters only. Age 35, living with brother, John, in Calhoun Co.

TAYLOR, Benjamin, Private. Company M, 1st West Virginia Cavalry, enlisted 1865, discharged 1865.

TAYLOR, Levi J., Co. A 3rd Virginia State Line (Moccasin Rangers). Enlisted on 1 Nov. 1862 in Nicholas Co., Va. Present on 28 Feb. 1863. Private, Co. A, 19th Virginia Cavalry. Born Gilmer Co., W.Va. about 1845. Age 15, Calhoun Co. 1860 Census. Enlisted Williamsburg, Greenbrier Co., W.Va., 1 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863. Confederate States Record filed as Lin J. Taylor. May also have served in Co. E, 14th Virginia Cavalry. Possibly buried in Yellow Creek area. Son of Jesse and Jane Burrows Taylor. C.S.A.

TAYLOR, Wiley H. (Haskins), born 21 July 1837, died 27 Nov. 1903. Enlisted Aug. 1862, discharged July 1865. In battles of Cedar Creek, Winchester, Fisher's Hill, Gettysburg, and Appomatox. Stewart GTE WKS Mannington, W.Va., Grand Army Recovery.

TAYLOR, William A., Private, born Buckingham Co., Va. Enrolled 1 Mar. 1862 at Weston, Lewis Co., for three years, Company G, 10th Regt., Virginia Infantry (later West Virginia Infantry), Pension No. 163635. Wounded in action at Singers Ferry, Va., 17 July 1864. Honorably discharged 9 Aug. 1866 because of sickness. Died 16 Jan. 1866 from tubercular consumption. Union.

TAYLOR, William M., 14th Virginia Cavalry. C.S.A.

THOMAS, Henry J., Private, Pennsylvania Infantry. Enlisted 1861, discharged 1865. Union.

THOMAS, Isaac H., Private, Company A, 2nd Virginia Infantry. Enlisted Aug. 1861, discharged Aug. 1862. C.S.A.

Enlisted at Williamsburg, Va. on 1 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863. Clothing issued, 5 Feb. 1864, 19 Feb. 1864, 17 June 1864 and 25 Aug. 1864. Signs by X. Born in Kanawha Co., Va about 1842. Age 18, serving, Calhoun Co., 1860 Census. C.S.A.

TRIPPETT, Caleb, Co. A 3rd Virginia State Line (Moccasin Rangers). Private, Co. A, 19th Virginia Cavalry. Born Monongalia Co., W.Va. about 1845. Age 15 1860 Calhoun Co. Census. Enlisted Williamsburg, Greenbrier Co., W.Va., 1 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863. Clothing issued 29 Feb. 1864 and 30 Apr. 1864. Brother of Philip, son of Franklin. C.S.A.

TRIPPETT, Franklin, Co. A 3rd Virginia State Line (Moccasin Rangers). Enlisted on 1 Jan. 1862 (15 June 1861) in Greenbrier Co., Va. Present on 28 Feb. 1863. Private, Co. A, 19th Virginia Cavalry. Born Monongalia Co., W.Va. about 1809. Age 51, farmer, Calhoun Co. 1860 Census. Father of Philip and Caleb. Calhoun County History shows that he had three sons in the 19th Virginia Cavalry, but it does not name them. C.S.A.

TRIPPETT, Philip, 1st Corporal, Co. A 3rd Virginia State Line (Moccasin Rangers). Enlisted 15 June (July) 1861 in Calhoun Co., Va. Father, Franklin, and brother said to have enlisted the same day. Deserted at Lewisburg, Va. on 15 Feb. 1863. 2nd Lt, Co. A, 19th Virginia Cavalry. Born Monongalia Co., 28 Dec. 1838. Moved to Calhoun Co. December 1853. Age 21, Calhoun County 1860 Census. Transferred to Co. A, 19th Virginia Cavalry. Promoted to 2nd Lt, 1863. Paid for service, 1 Jan. 1864 to 31 Aug. 1864 as Jr. 2nd Lieutenant. Absent 25 Oct. 1864. Absent without leave for 33 days, no steps taken to have him dropped from the rolls. Dropped as 2nd Lt, Co. A on 31 Jan. 1865. Post war farmer, Sheridan District, Big Bend, Calhoun County, W.Va. TRUMAN, Robert, Private, Co. I, Virginia State Line. Private, Co. K, 19th Virginia Cavalry. Born Gilmer Co., about 1849. Age 11, Calhoun County 1860 Census. Enlisted Frankfort, Greenbrier Co., W.Va. 20 Mar. 1863. Not stated if present or absent on muster-inrolls dated March 1863. C.S.A.

TUCKER, James M., Co. A, 3rd Virginia State Line (Moccasin Rangers). Enlisted on 1 Dec. 1861 in Calhoun Co., Va. Status not stated on 28 Feb. 1862 muster-in-roll. Private, Co. A, 19th Virginia Cavalry. Post war rosters only, which show he was a resident of Calhoun Co., W.Va. C.S.A.

TUCKER, John T. P., Private, Company B, 9th West Virginia Infantry. Enlisted 16 Sept. 1861, discharged 5 Oct. 1864. Injury by marching. Union.

UMSTEAD, James W., Corporal, born 7 Oct. 1831, died 23 Aug. 1927 in Huntington, buried Mt. Zion Cemetery, Calhoun County. Enlisted 1 June 1861, discharged 16 June 1864, Company E, 2nd West Virginia Infantry and Company E, 5th West Virginia Cavalry. Chaplain. Was in ten skirmishes and battles including second battle of Bull Run where he was wounded. Citation states "Wounded Waterloo Bridge." Union.

UPTON, Ulysses W., Private, Company B, 9th West Virginia Infantry. Enlisted 15 Dec. 1861, discharged Jan. 1865. Union.

VANDEVENDER, George A. (H.), 3rd Sergeant, Co. H, 20th Virginia Cavalry. Born about 1843. Enlisted Camp Northwest 1 June 1863 (8 Apr. 1863; Calhoun Co, 9 May 1863.) Not stated if present or absent on muster-in-roll dated August 1863, 3rd Sergeant. Absent, Private, 31 Oct. 1863-31 Aug. 1864, in hands of the enemy. Captured Calhoun County, 4 Dec. 1863. Confined at the Atheneum Prison, 12 Jan. 1864. Description: Age 20, 5' 8-3/4" fresh complexion, dark hair and dark eyes. Occupation, farmer, residing in Calhoun County. Took the oath of allegiance, gave his bond and was released, 28 Jan. 1864. Absent 1 Sep. 1864-31 Oct. 1864 (dated 30 Dec. 1864), prisoner, captured October 1863. Age 37, farmer, Center District, Calhoun 1880 Census. C.S.A.

Tried by a U.S. Court in western Virginia, 14 Apr. 1862, for robbing the Post Office at Ripley, W.Va. Convicted and sentenced to three years in prison. Confined at Albany, N.Y. before June 1863. Released 4 June 1863 by Presidential Pardon, dated 1 June 1863. Post war resident of Calhoun County, W.Va. C.S.A.

WAITE, James W., born 1842, died Aug. 1864. Shot by bushwhackers in Johnson Co., Mo., by mistake being taken for

another man.

WAITE, Samuel C., born 1838, died Sept. 1864, was with Horton's battalion, Jubal Early's brigade. Was killed at Leetown, Va. C.S.A.

WALKER, Andrew, Private, died 26 June 1900, buried Bethlehem Cemetery, Company F, 2nd Regt., West Virginia Cavalry. Enlisted 19 Nov. 1861, discharged 30 June 1865. Union.

WATKINS, Francis M., Private, born 11 Dec. 1838, died 11 Feb. 1910, buried Cooper Cemetery. Company I, 11th West Virginia Infantry. Wounded at Winchester, Va., 24 July 1864. Union.

WAYNE (WAIN), Henry M., Co. A, Virginia State Line (Moccasin Rangers). Private, Co. A, 19th Virginia Cavalry. Born Gilmer Co., about 1845. Age 15, Calhoun County 1860 Census. Not on muster rolls. Captured Calhoun Co., 1 Nov. 1863. Confined at the Atheneum Prison, 20 Nov. 1863. Description, age 19, 6', light complexion, brown hair, and blue eyes. Occupation, farmer residing in Calhoun County, W.Va. Transferred to Camp Chase, 20 Nov. 1863. Confined at Camp Chase 21 Nov. 1863. Admitted Chase USA General Hospital, 12 Mar. 1864, smallpox, age 19. Returned to duty, 27 Mar. 1864. Desires to take the oath of allegiance, 10 June 1864, says he is a deserter. Died of disease, Camp Chase, 16 Aug. 1864, typhoid fever. Buried Camp Chase Confederate Cemetery, grave No. 207. C.S.A.

WAYNE, Jacob, [See PHOTO], Private, Company F, 11th West Virginia Infantry. Enlisted 1862, discharged 1865. Union.

WEAVER, Frank, buried Cooper Cemetery (9' South of Myrtle A. Downey's grave). Union.

WILSON, Wesley, Private, Company B, 9th West Virginia Infantry. Enlisted Sept. 1861, discharged Oct. 1864. Wounded in thigh at Cloyd's farm, 9 May 1864. Union.

WISEMAN, George M., Private, Company D. 11th West Virginia Infantry. Enlisted 25 Sept. 1862, discharged 1865. Receiving \$4.00 per month pension for gunshot wound of left hip and finger on 1883 Pension Roll; address, Grantsville. Union.

WOOD, William H., Corporal, born 15 Jan. 1844, died 10 Mar. 1917, buried Mt. Zion Cemetery, Company F, 4th Regt., West Virginia Infantry. Enlisted 23 Aug. 1861, discharged 18 July 1865. Union.

WRIGHT (RITE), George W., Co. I, 3rd Virginia State Line. 2nd Corporal, Co., K, 19th Virginia Cavalry. Born Kanawha Co., W.Va. about 1823. Age 37, farmer, Calhoun Co., W.Va. 1860 Census. Enlisted Frankfort, Greenbrier Co., W.Va. 20 Mar. 1863. Not stated if present or absent on muster-in-roll dated March 1863, 2nd

Corporal. C.S.A.

WYATT, Jasper, Sergeant, born 1822. Mustered 28 Dec. 1863, Company E, 6th Regt., Infantry. Union.

YEAGER, Alfred, Private, born about 1830, Randolph Co., Va. (An Alfred Yeager born 1840, died 1906 is buried St. Paul Cemetery.) Company C, 8th West Virginia Cavalry. Enlisted Aug. 1861, discharged Aug. 1864. Union.

YEAGER, Isaac, Private, born about 1834, Randolph Co., Va. Mustered 5 Sept. 1864, Company F, 17th Regt., Infantry. Union.

YOKE (Yoak), Isaac, Private, born 29 June 1829, died 30 Sept. 1908, buried Sand Ridge Cemetery. Company I, West Virginia Infantry, Company C, 10th Regt., West Virginia Infantry, transferred to Company O. Enlisted 15 Mar. 1862, discharged 9 Aug. 1865. Wounded at Winchester, Va., 24 July 1864. Union.

ZUMBRO, William A., Private, born 1842, Company A, 6th West Virginia Infantry. Enlisted Aug. 1861, re-enlisted 24 Aug. 1864, discharged Oct. 1865. Union.
